II: MINUTES: Linda Laird

Minutes of the August 22, 2025 gathering were approved as distributed. Laura made the motion to approve the minutes and Wayne seconded the motion. All approved.

III: FINANCE: Kevin Sevier, Vestry Member

Treasurer's Report for Month Ending August 31, 2025:

Revenue Discussions:

Income and giving have slowed as we move through the third quarter of 2025. After making budget adjustments, we are ahead of budget on income and below budget on expenses.

August monthly Income finished at \$262,900.91 to a budget of \$287,401.50.

Comparatively, July 2025 monthly income was \$231,548 (Historically there has been a lull in giving/income each summer over the last 8 years as discussed in Finance Committee...it occurs in June or July each summer). Income has also been adjusted back to June 2025 per the Finance Committee to include interest from the IntraFi accounts. That interest has previously been placed in the Argent designated fund; however, we will include it in our operating account for the time being to assist with cash flow.

Monthly Plate/Pledge Income was \$178,745.76 to a budget \$209,715.00.

August Plate/Pledge income variance is -\$30,969.24.

Total Income for the month was lower than budgeted by \$24,500.59.

Note: Total income includes Giving, Bequests, Missions, Faith Formation and Counseling Center revenue

God's Goods Income transferred to the Missions Fund for August was \$106,591 compared to July GG income of \$52,692

Expenses Discussion:

Overall expenses were lower than budgeted.

Total expenses for the month were \$299,456.96 to a monthly budget of \$329,660.91.

The monthly expenses budget variance is under by \$30,203.95

We have a total variance of income over expenses by \$148,276.31.

IV: Other

A. Status of the Cross Schools-construction projects: Wayne

The certificate of occupancy inspection was scheduled for Friday, 9/19/25. It was not issued because the certificate of compliance inspection failed due to two issues with the pervious concrete installation. Also, for the certificate of occupancy to be issued, slow-closing door closers must be installed on the three, new single-use A.D.A. restrooms. These are expected to be installed during the middle of the week of 9/21/25. Since 10-12 days are required for the faulty concrete demolition, re-pouring of concrete, curing and re-striping, reinspection is scheduled for 10/2/25.

B. Update on the Chapel columbarium: Fr. Owens

The columbarium is near completion. After placement of the lettering on the back wall and setting of the gates, the water will be activated and all will be complete.

C. Desire by the Cross School Board to consolidate the Argent East project and the development of the high school vision: Michael, Craig and Kevin

The Board has united in their direction to focus on one project at a time. Kim Clark is an asset to the board because of her experience with preschool development. She can correctly address the specifics of class size and the number of children from dippers to 6 years. We are waiting for the Bluffton Council to approve the blueprint (Phase 1) for the high school. There will be a pause on all projects until every detail is clear. We are seeing great progress with everyone contributing to the discussion.

D. Severance pay for Nathan Weaver

There was a motion brought from Laura Strange that it was common to the Jurisdiction of Chaplains to offer a severance payment to Priest's when they leave an assignment. When Nathan was pulled from the Parish, Bishop Jones suggested to Father Owens that the parish pay Nathan's salary through October, which would be a 3 month severance. The Vestry discussed Laura's motion and we agreed to pay Nathan through the remainder of 2025 or an additional 2 months for a total of 5 months. The motion was voted on and approved by all members.

VI: Closing Prayers Joanne closed us in prayer and all said "Amen."

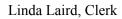
